

## ABSFRONT SOFTWARE TERMS OF USE

SOFTWARE: Absfront Accelerator 365

This software Terms of Use (the "Terms") is entered into , and shall become effective, as of the date the Software has been downloaded from Appsource or other cloud resources and installed in to your (the Licensee) tenant/solution.

These Terms applies to each software program licensed by Absfront to Licensee, and documentation provided with such software program, and any patch, update, upgrade, modification or other enhancement provided by Absfront with respect to such software program or documentation, unless Licensee has a separate legally enforceable written agreement for such with Absfront.

### OWNWERSHIP AND LICENSE GRANT

Except for the license expressly granted in this Agreement, Absfront and Third Parties that have ownership interest in and to the Software shall retain all right, title and interest to the Software, including all copyrights and other intellectual property rights thereto, and any copies of the Software or Documentation, whether authorized or unauthorized. Licensee acknowledges that the Software contains confidential information that is proprietary to Absfront.

Subject to the terms and conditions of this Agreement, Absfront hereby grants to Licensee a personal, non-transferable, non-exclusive, and non-sublicensable license to use the Software (the "License") for Licensee's internal business operations.

The Licensee has the following License types option:

**Trial License:** The Licensee can use Software for a period of 60 days counting from the date the Software was downloaded. After this time-period the Licensee is required to uninstall the Software or to choose the License type below.

**Subscription license:** By paying subscription license in the conditions and by the rate provided at [www.absfront.com](http://www.absfront.com) or via [sales@absfront.com](mailto:sales@absfront.com) the Licensee can use the Software as long as payments have been made according to the terms stated by Absfront via above provided communication channels.

**Source Code License:** Can be provided after additional Agreement with Absfront.

### LICENSE RESTRICTIONS

Licensee may not reverse engineer, decompile, or disassemble the Software for any purpose. Each Software product will be identified with one product code and although a product might be described as a suite or a bundle, it shall be used as one product by one user and not as multiple products or components. Where the Software includes programs from other licensors, Licensee agrees to use Absfront's licensors' programs solely in conjunction with the Software as provided. Licensee accepts that all information gained about the Software is the valuable property of Absfront and as such must be treated as confidential. Licensee warrants that it will not sell, license, lease, rent, loan, lend, transmit, network, or otherwise distribute or transfer the Software Licensee may not use the Software to conduct a service bureau, application service provider (ASP), software-as-a-service provider or similar business for the benefit of third parties. Licensee is expressly prohibited from adapting, modifying, revising, improving, upgrading, or enhancing the Software for any purpose

including error correction or any other type of maintenance, except as expressly allowed in the Documentation.

Upon request by Absfront, Licensee must permit Absfront or a third party designated by Absfront to have access to Licensee's records and computer systems and the right to audit Licensee's systems to ensure Licensee is using the Software in accordance with the license terms set out in this Agreement. Licensee shall, at its own cost, give reasonable assistance to enable Absfront to conduct such audit in an efficient manner. The cost for Absfront's audit will be borne by Absfront unless the audit shows that Licensee has used the Software in breach of the Agreement, in which case the costs for the audit shall be borne by Licensee. In the event of such breach of Agreement, Licensee shall further compensate Absfront for the breach.

#### CONFIDENTIALITY

Licensee agrees and acknowledges that the Software and any information and materials including methodologies and know-how relating in and to the Software is confidential information and contains trade secrets of Absfront and third parties having ownership interest in and to the Software, and shall be held in the strictest confidence by Licensee and shall not be copied, reproduced, or disclosed, to any third party for any purpose whatsoever other than for Licensee's internal business purposes as set forth in this Agreement. Licensee agrees to use at least the same security measures as it uses to protect its own confidential and trade secret information, but no less than reasonable measures. Confidential information does not include information which Licensee can demonstrate:

- (i) was, at the time of disclosure to Licensee, generally part of the public domain or thereafter becomes generally part of the public domain through no act or omission of Licensee; or
- (ii) was lawfully in Licensee's possession as shown in written records prior to such disclosure and without obligation of confidentiality; or
- (iii) was lawfully received by Licensee after disclosure from a third party without obligation of confidentiality and without violation by such third party of an obligation of confidentiality to another; or
- (iv) was required to be disclosed by law or court order from a court of competent jurisdiction provided that Absfront is given reasonable time to take legal action to oppose such action and seek other protection.

Licensee shall not alter or delete any copyright or trademark notice, trade name, or other markings which identify Absfront's proprietary rights and interests in the Software and documentation.

Licensee agrees and acknowledges that any breach of the provisions regarding the ownership, license grant, license restrictions, or confidentiality contained in this License shall cause Absfront irreparable harm and Absfront may obtain injunctive relief as well as seek all other remedies available to Absfront in law and in equity, including but not limited to full compensation for any damages suffered by Absfront, without bond.

#### LIMITED WARRANTY

Absfront warrants that the Software will operate substantially according to specifications published by Absfront for a period of ninety (90) days from the date of delivery of the Software (the "Warranty Period"). If Licensee notifies Absfront during the Warranty Period that the Software does not meet the limited warranty contained in this section, Absfront will, at its option, either (i) return the

amount paid for the Software during the 12 months prior to the filing of the claim, or (ii) update such Software to make it conform. Said refund or update shall be Licensee's sole remedy and Absfront's exclusive liability under the limited warranty set forth in this section.

Absfront does not warrant that the Software will meet Licensee's requirements or that the operation of the Software will be uninterrupted and error free. Licensee is solely responsible for the selection of the Software to achieve its intended results and for the results actually obtained.

The above warranty does not apply to conditions resulting from improper use, external causes, including service or modifications not performed by Absfront or Absfront's appointed contractor, or operation outside the specified environmental parameters. Absfront will not be responsible for operation of the Software other than in conjunction with the operating environment designated for each version of the Software.

EXCEPT FOR THE LIMITED WARRANTIES SET FORTH IN THIS SECTION , ABSFRONT SPECIFICALLY DISCLAIMS ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE SOFTWARE, DOCUMENTATION, AND ALL THIRD PARTY COMPONENTS, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, ABILITY TO ACHIEVE ANY PARTICULAR RESULT, TITLE OR NON-INFRINGEMENT. THESE DISCLAIMERS WILL APPLY UNLESS OTHERWISE REQUIRED BY APPLICABLE LAW.

#### LIMITATION OF LIABILITY

THE USE OF THE SOFTWARE, ALL RESULTS OF SUCH USE AND ALL CONSEQUENCES ARISING THEREFROM ARE THE SOLE RESPONSIBILITY OF LICENSEE. ABSFRONT SHALL NOT BE LIABLE TO LICENSEE FOR ANY LOSS OR DAMAGE CAUSED ARISING DIRECTLY OR INDIRECTLY AS A RESULT OF SUCH USE OF THE SOFTWARE BY LICENSEE.

ABSFRONT'S LIABILITY WITH REGARD TO LICENSEE UNDER THIS AGREEMENT SHALL UNDER ALL CIRCUMSTANCES BE LIMITED TO DIRECT DAMAGES UP TO AGGREGATE LICENSE FEES FOR THE SOFTWARE PAID BY LICENSEE HEREUNDER, OR IN THE EVENT OF SOFTWARE-AS-A-SERVICE LICENSE THE LICENSE FEES PAID DURING THE MOST RECENT TWELVE (12) MONTH PERIOD PRIOR TO THE CLAIM. THIS LIMITATION APPLIES REGARDLESS OF WHETHER THE LIABILITY IS BASED ON BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, BREACH OF WARRANTIES, OR ANY OTHER LEGAL THEORY, WITH THE EXCEPTION OF DAMAGES DUE SOLELY TO ABSFRONT'S WILLFUL MISCONDUCT OR GROSS NEGLIGENCE OR DAMAGES.

ABSFRONT SHALL IN NO EVENT BE LIABLE TO LICENSEE UNDER THIS AGREEMENT FOR ANY SPECIAL, INDIRECT, INCIDENTAL, EXEMPLARY, OR CONSEQUENTIAL DAMAGES, OR FOR LOSS OF DATA, USE AND/OR PROFITS, GOODWILL, CLAIMS FOR SERVICES INTERRUPTIONS, DOWNTIME COSTS AND CAPITAL COSTS OR CLAIM OF A THIRD PARTY, TO THE EXTENT PERMITTED BY LAW, UNDER ANY LEGAL THEORY WHETHER ON ACCOUNT OF DEFECTS, PERFORMANCES, NON-PERFORMANCES, DELAYS OR FAILURE TO SUPPLY, PERSONAL INJURIES, PROPERTY DAMAGES OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR IF SUCH POSSIBILITY WAS REASONABLY FORESEEABLE. Licensee agrees and acknowledges that any breach of the provisions regarding export control regulations set forth herein may cause Absfront irreparable harm and Absfront may obtain injunctive relief as well as seek all other remedies available to Absfront in law and in equity, including but not limited to full compensation for any damages suffered by Absfront, without bond.
